Recruitment and appointment of Trustees

The board may at any time appoint any person to be a charity trustee by way of a resolution passed by majority vote at a board meeting.

Governing document

The charity is a Scottish Charitable Incorporated Organisation and the purposes and administration arrangements are set out in the constitution.

Charitable purposes

The purpose of the charity, as recorded in the constitution, is the provision of horticultural therapy to serving or former members of the military or emergency services suffering from mental illness or physical disability.

Activities and achievements

It has been a year of major change in our therapist team. Zisky Stovell succeeded in her long term ambition of gaining entry to RMA Sandhurst and Mike Snowden stood down as a full time employee although he continues to help us on a consultative basis. They were the driving force in the setting up of the Garden, the recruitment of volunteers and the introduction of veterans. They started off with a barren site and an empty building and transformed it into a warm and welcoming place staffed by friendly volunteers. The charity owes them a huge thank you for all their work.

We have been extremely fortunate in being able to recruit a new team. Christian MacGregor did national service in the Swiss Air Force, is experienced in medical and social care and has a Doctorate in Counselling Psychology. Carol Pickthall is an experienced horticulturalist who has been married to a naval officer for many years and understands the demands of military life. Prior to having her family, Carol was a registered general nurse with extensive experience in A & E. Ian Forbes joined us as a volunteer after retiring from a civilian job with Police Scotland. He is now employed to provide holiday cover while also retaining his volunteer status.

The Garden is now officially open. The Lord Provost of Dundee, Ian Borthwick, accepted our invitation to open the Garden on 24th August. He planted a tree with considerable panache watched by a large crowd of staff, veterans, volunteers and their families along with several local

politicians. All our funders were invited and we were happy that a considerable number were able to attend.

Our veteran numbers have remained more or less the same this year. It is difficult to predict the length of time that veterans will need to stay with us before progressing on to further opportunities. We have been very pleased with the speedy recovery of a number of our veterans and the fact that they have been able to reintegrate with family and friends. Two veterans have successfully entered full time education.

We have been working hard to expand our range of contacts in the community. We were the only veteran's charity to be selected for the Green Health Partnership, put in place by Scottish Natural Heritage which chose Dundee as one of 4 pilot schemes in Scotland. Managed by Dundee City Council and NHS Tayside, the scheme aims to improve health by offering alternatives to drug based therapies. We have now been in direct touch with every GP practice in the city. We have attended various Royal British Legion Scotland breakfast clubs in the area. In October, COBSEO, The Confederation of Service Charities, granted us full membership.

Our volunteers are vital for the continuing success of the Garden. We are very grateful to all the individuals who contribute so much and also to professional offices such as Thorntons Law and Brewin Dolphin who send volunteers to us.

None of this would happen without the generosity of our donors. A separate list of all financial contributions is attached to this report.

The accounts this year show a substantial surplus. This is in part due to the late arrival of a donation from last year and projects coming in well under budget. This is particularly true of the reconstruction and refurbishment of our kitchen and mess room which was carried out completely free of charge by the City Council and a number of local companies. These companies have all been listed separately with our donors.

The charity is fully funded for this current year and we are making good progress for the next financial year.

Trustee remuneration and expenses

The trustees did not receive any remuneration or expenses during the year.

Reserves

As a result of a surplus for the year of £42,897, the Charity held unrestricted funds at the period end of £104,403. The Charity held no restricted funds.

The current year's surplus will enable the Trustees to increase reserves to just over £40,000. We will thereby fulfil our aim of having a reserve of approximately 50% of operating costs in line with OSCR recommendations.

Independent Examiner's Report to the Trustees of Dundee Therapy Garden

I report on the accounts of the charity for the year ended 31 March 2019 which are set out on pages 1 to 5.

Respective responsibilities of trustees and examiner
